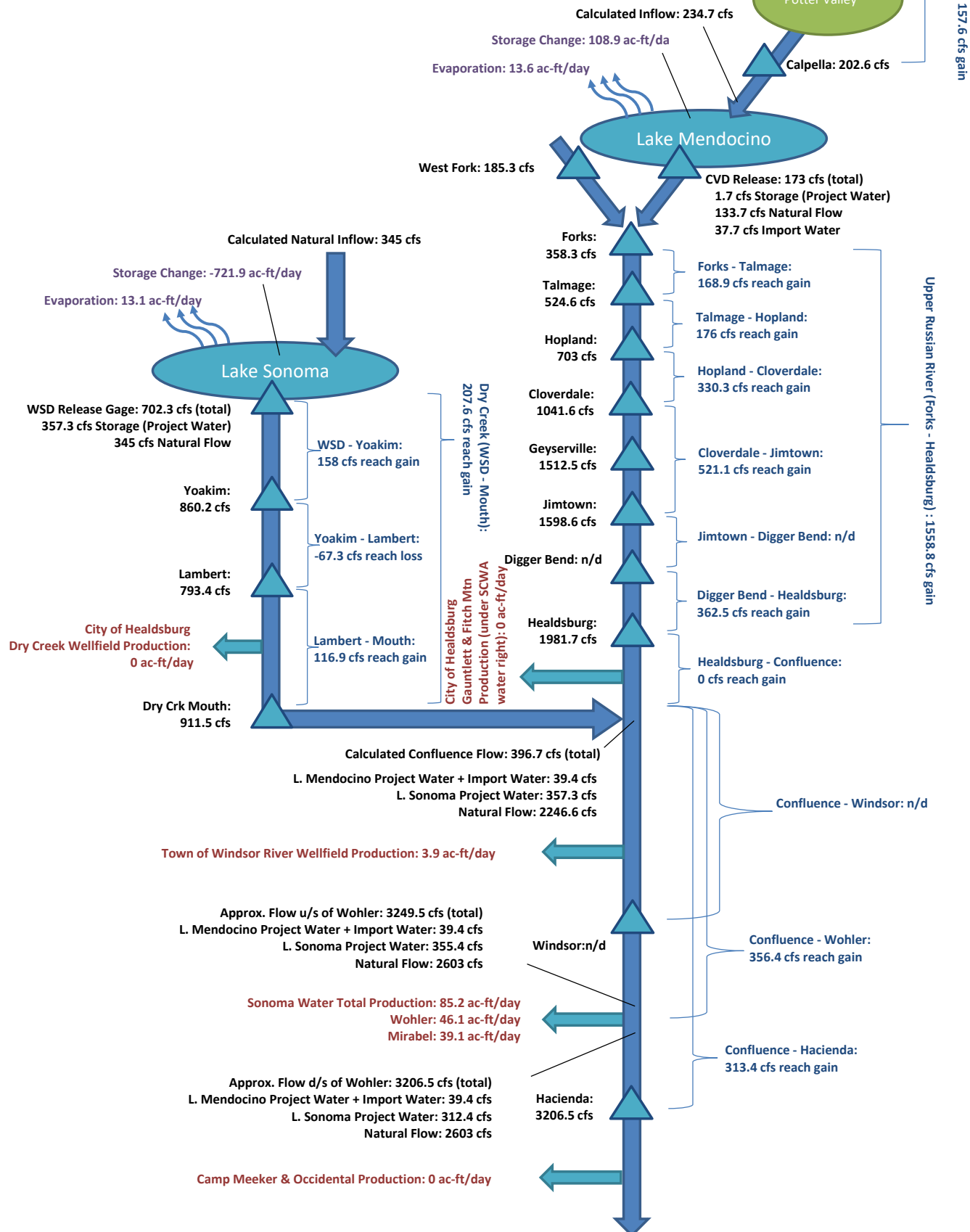

Reach losses are calculated using estimated travel times, and are reported here as weekly averages.

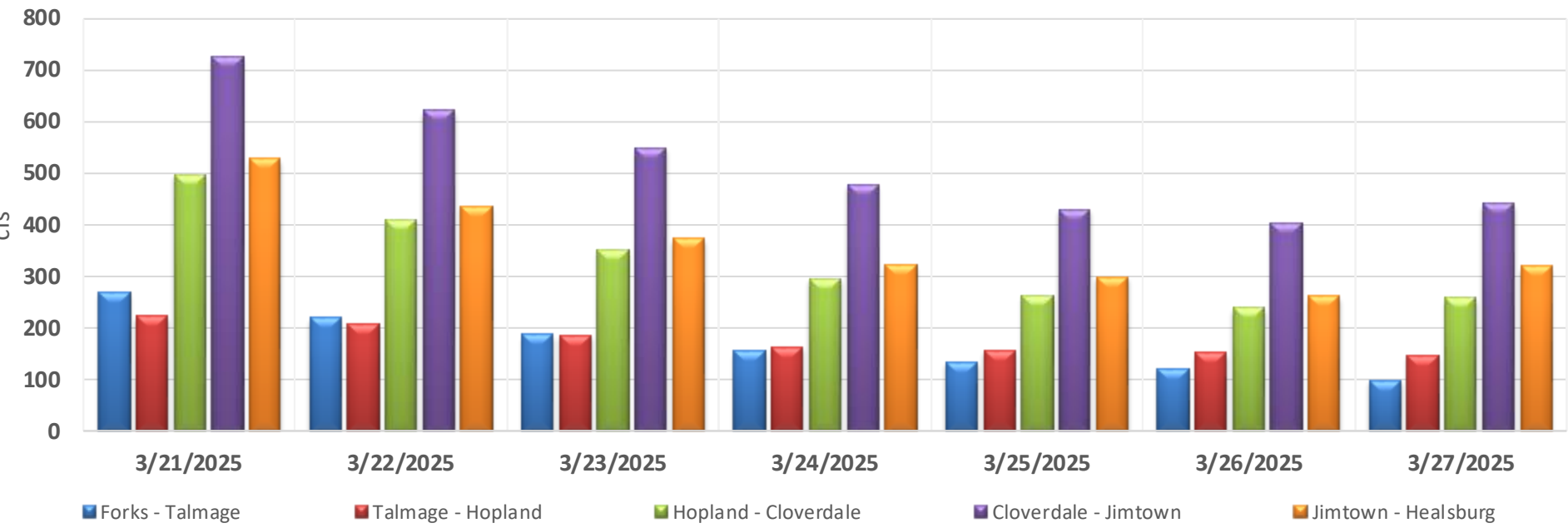




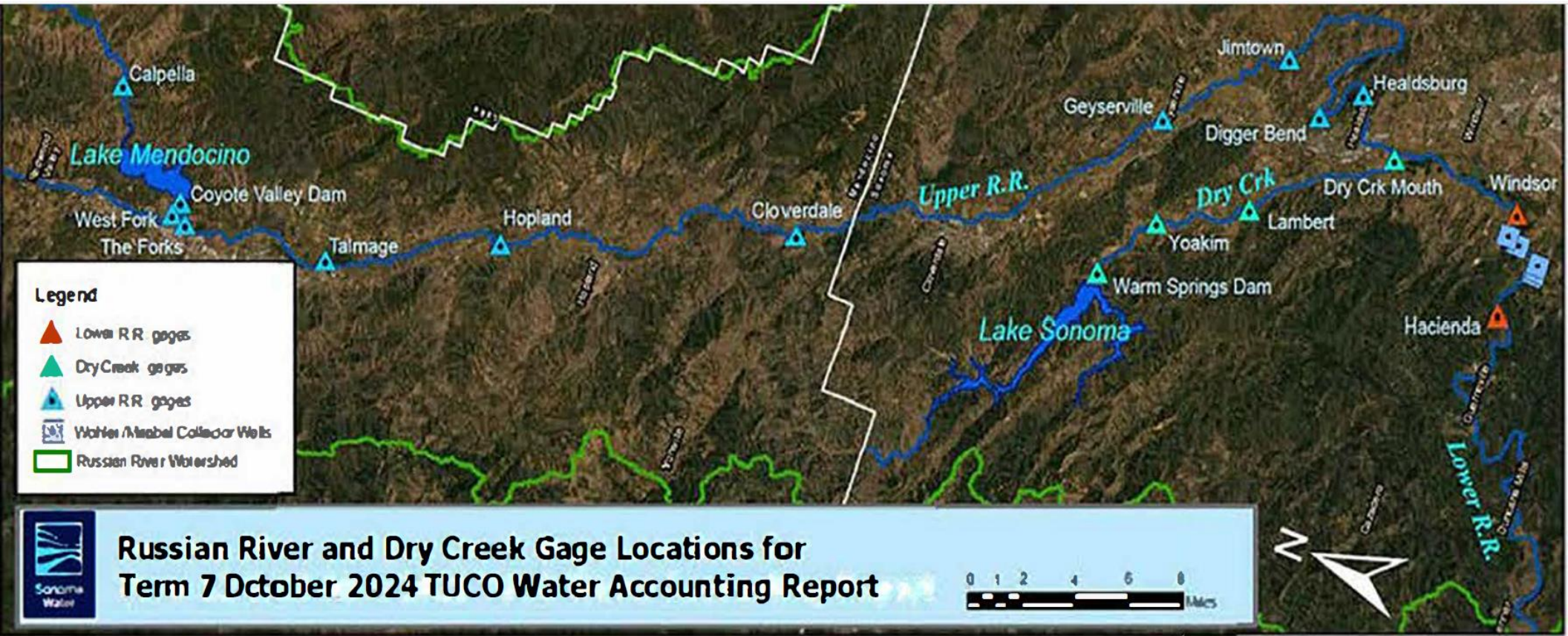
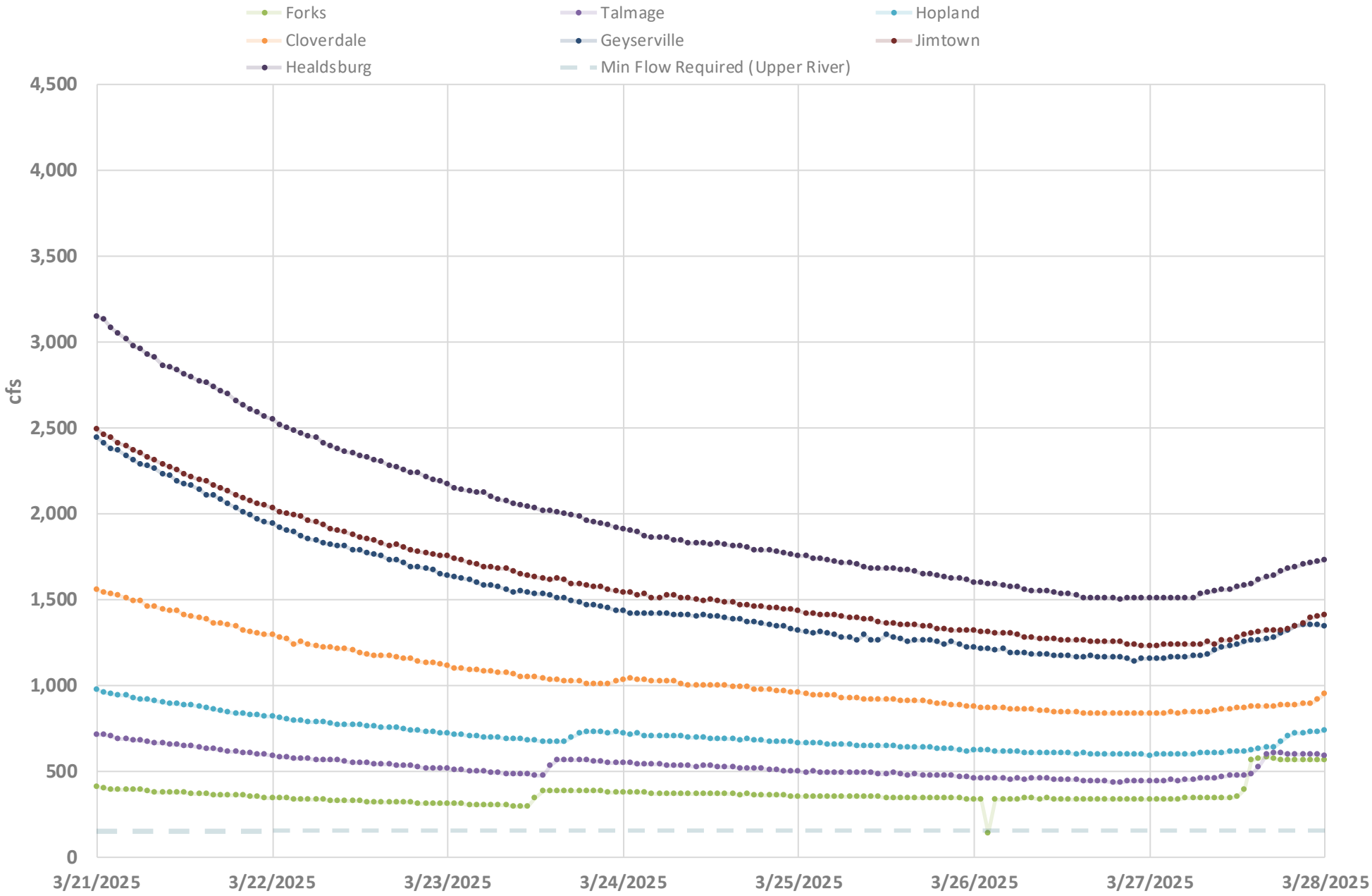

UPPER RUSSIAN RIVER STREAM FLOWS

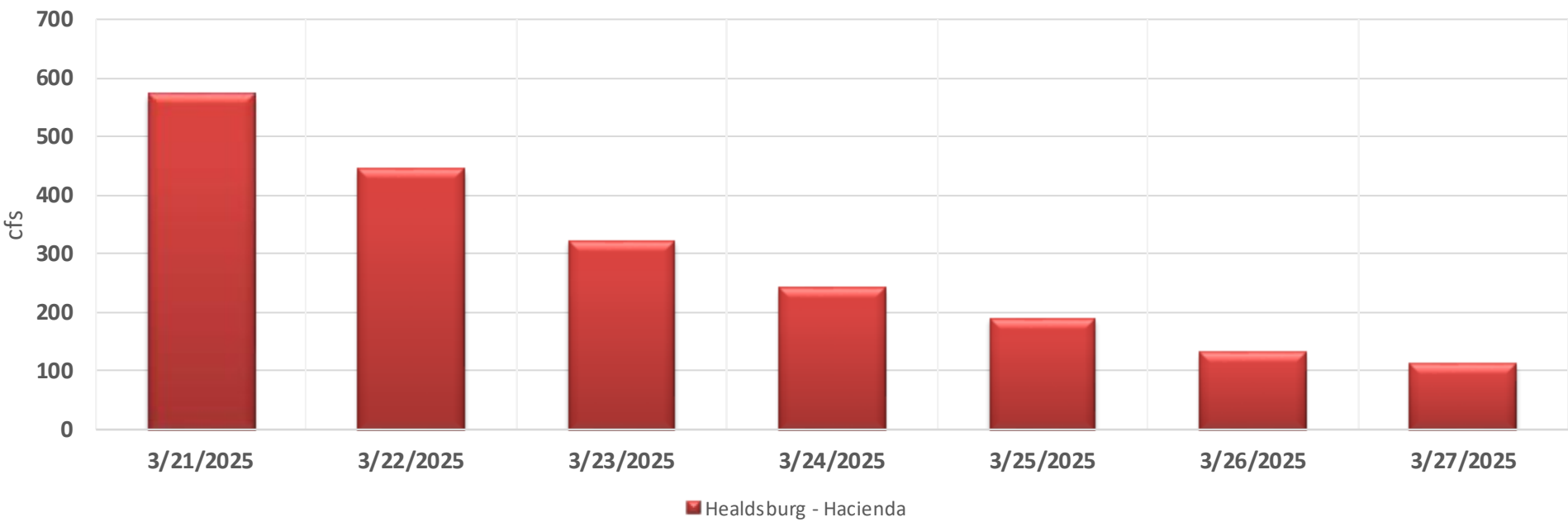
