Proof of publication shall consist of an affidavit of the publisher or foreman of the newspaper, attached to a copy of the notice, as published. Failure to comply with these requirements shall result in the automatic termination of the temporary change order.

Parties filing objections to the petitions shall furnish the Petitioner, as well as this office, a copy of their objections. We will then notify the Petitioner of the objections to which it must respond.
