

How to Participate

- 1. Read and understand the Program Eligibility and Rules.
- 2. Determine if your home is connected to a participating sanitation system listed on the front (Page 1). Look on your property tax bill for a line item stating the sanitation district or zone you are connected to or call (707) 547-1918 for assistance.
- 3. Purchase and install your qualifying 0.8 gallon per flush or less high-efficiency toilets (HET) between July 1, 2023 and June 30, 2024. **Be sure that the toilets are on the List of Qualifying Models** and that the **model numbers match exactly.**
- 4. Complete and sign the application form below and an IRS Form W-9. Mail along with **original** purchase receipts/plumbers invoices to:

- 5. Please allow 6 to 8 weeks to process your rebate requests. Checks will be mailed to the address provided below.
- NOTE: Rebate amount cannot exceed the cost of the HET excluding accessories, extended warranties, service plans, sales tax, delivery, installation or other fees.

Program Eligibility and Rules

- 1. Rebates are available July 1, 2023 through June 30, 2024 on a first come, first served basis while funding lasts.
- 2. Your home has an active sewer connection with a participating sanitation system and was built before 1992. Homes built in 1992 or later are required to have low flow toilets installed during construction.
- 3. The toilets you are replacing are designed to flush at more than 1.6 gallons per flush (generally, toilets manufactured before 1992).
- 4. Your new toilets have been installed at the property listed below and your rebate application is received or postmarked within 90 days of purchase or delivery. All purchases must be made between July 1, 2023 and June 30, 2024 to be eligible.
- 5. Your new toilets use a maximum of 0.8 gallons per flush and is listed on the List of Qualifying Models on Page 1.
- 6. Your old toilets were properly recycled.
- 7. A **completed and signed IRS Form W-9** must be included with your application. A 1099-MISC form may be issued if combined rebate incentives from the County of Sonoma total \$600 or more per tax year. Download the W-9 form at https://www.irs.gov/pub/irs-pdf/fw9.pdf
- 8. Incomplete applications and those submitted without a completed IRS Form W-9 and original purchase receipts will be returned.
