December 10, 2024**

Meeting Minutes

General notes: This was a regular meeting of the Flood Protection Zone 3A Advisory Committee (Committee). 1. Opening and Introductions. Chase Takajo called the meeting to order at 1:05 p.m. Attendees self-introduced. The Committee quorum was present.
2. **Public Comment on Agenda Items.** None stated.
3. **Approval of Meeting Minutes.** The Committee approved the minutes of the December 7, 2023 meeting as submitted.
4. **Sonoma Valley Hydrologic and Hydraulic Modeling Project.** James Gregory presented a summary of the project background, application of the model, preliminary flood reduction project alternatives, ongoing work and next steps. 5. **Stream Maintenance Program.** Chase Takajo presented a summary of the stream maintenance activities completed in 2024 and Sonoma Water's real-time rainfall, river-stream and reservoir data website (<https://sonoma.onerain.com>). - 7. **Fiscal Year 2025/2026 Flood Control Budget.** Chase Takajo and Carlos Diaz presented the recommended fiscal year 2025/2026 flood control budget and summarized the purpose and status of each budgeted item.
